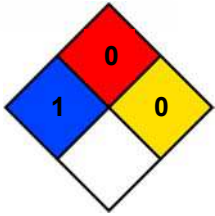

## SECTION 2: HAZARDS IDENTIFICATION

### HAZARDS OVERVIEW:

A clear amber liquid having a characteristic odor. The liquid and mists may be irritating to the eyes and skin. Inhalation of mists may be irritating to the entire respiratory tract. Ingestion of this product may cause gastrointestinal irritation, cardiovascular and central nervous system effects.

#### SECTION 4: FIRST AID MEASURES
