# INSTRUCTIONS

- To prepare the spray mixture, fill the mix or spray tank with three-fourths of the required amount of water then add the proper amount of FERTILGOLD<sup>®\*</sup> TRIPLE PLAY<sup>®\*</sup>.
- Complete filling the mix or spray tank with the balance of water needed.
- Mix continuously.
- Determine compatibility with other additives by performing a jar test using appropriate quantities of each material and water.
- As this product functions mostly on contact, the more complete the coverage, the better the product performs.
  Ensure application of the spray solution on both sides of the foliage.
- For best results, apply in early morning or late in the afternoon.
- Do not apply in rainy or windy conditions or on water-stressed plants.
- Use volume of water necessary for uniform and 360° spray coverage of foliage without running off.
- Use lower rates for light infestations, moderate rates for moderate infestations, and higher rates for heavy infestations.
- Apply spray solution in properly maintained and calibrated equipment capable of delivering the desired volumes.

#### **STORAGE AND HANDLING**

Store in a cool, dry, well-ventilated area, away from incompatible materials and products. To protect eyes and skin from contact with this product, applicators and other handlers must wear a long-sleeved shirt, long pants, shoes and socks, protective eyewear and chemical resistant gloves made of neoprene, nitrile or natural rubber. Avoid breathing vapors, aerosols or mists. Use with adequate ventilation. Do not take internally. Keep the container tightly closed when not in use. Wash thoroughly with soap and water after handling this product.
