

## INSTRUCTIONS

- It is important when using FERTILGOLD<sup>®</sup> PROMAX<sup>®</sup> as a protective or curative fungicide and nematocide that material be incorporated into the soil. This can be accomplished as a soil drench, mechanical incorporation or as an infurrow application watered in.
- The higher rates should be used on heavy soils, in fields with a history of disease problems, or when weather conditions are expected to be favorable for rapid disease growth or nematode activity.
- Determine compatibility with other additives by performing a jar test using appropriate quantities of each material and water.
- As this product functions mostly on contact, the more complete the coverage, the better the product performs.
- For best results, apply in early morning or late in the afternoon.
- Do not apply in rainy or windy conditions or on water-stressed plants.
- Use lower rates for light infestations, moderate rates for moderate infestations, and higher rates for heavy infestations.
- Apply spray solution in properly maintained and calibrated equipment capable of delivering the desired volumes.

## STORAGE AND HANDLING

Store in a cool, dry, well-ventilated area, away from incompatible materials and products. To protect eyes and skin from contact with this product, applicators and other handlers must wear a long-sleeved shirt, long pants, shoes and socks, protective eyewear, and chemical resistant gloves made of neoprene, nitrile, or natural rubber. Avoid breathing vapors, aerosols, or mists. Use with adequate ventilation. Do not take internally. Keep the container tightly closed when not in use. Wash thoroughly with soap and water after handling this product.

For use on all plants. Best results are achieved when used in a preventive program following recommended rates and application directions. FERTILGOLD<sup>®</sup> PROMAX<sup>®</sup> controls harmful soil-borne diseases and plant parasitic nematodes through contact activities. Carefully read, understand, and follow these label directions.

## SHAKE WELL BEFORE USE.

This product will separate.

Constant tank agitation is required to ensure a homogeneous spray mixture.

**FERTILGOLD<sup>®</sup> PROMAX<sup>®</sup> may be applied at any time up to and including the day of harvest.**

**Repeat application every 5 to 7 days to maintain the desired level of control.**
